RULES AND REGULATIONS FOR PARTICIPATION IN THE NEW YEAR'S EVE PARTY 2025/2026

§1

General Provisions and Scope of Application

- 1. These Rules and Regulations define the rights and obligations of the Organizer and the Participant and contain the general conditions of participation in the NEW YEAR'S EVE PARTY 2025/2026 (hereinafter referred to as the "Event"), organized by Oria Magic House Sp. z o.o. with its registered office in Gdańsk, Stara Stocznia 4/1 (hereinafter referred to as the "Organizer"), and set the terms and conditions for participation.
- 2. Participants of the Event are obliged to comply with these Rules and Regulations. The agreement is concluded and these Rules and Regulations are accepted by the Participant upon the purchase of a ticket. Payment is tantamount to reservation of a place and acceptance of these Rules.
- 3. The Event will take place at Oria Magic House, Stara Stocznia 4/1, Gdańsk.
- 4. The Event starts at 8:00 PM and ends at 2:00 AM.

Event Cost, Cancellation and Program Changes

- Tickets for participation in the Event may be purchased on-site at Stara Stocznia 4/1, Gdańsk, or by making a bank transfer to the Organizer's account: 88 1240 1545 1111 0011 0599 2546 – Oria Magic House, Stara Stocznia 4/1, 80-862 Gdańsk. The purchase of a ticket in any case constitutes acceptance of these Rules and Regulations.
- 2. Cost of participation in the Event:
 - a) In the first ticket sale pool, purchased up to November 15th, 2025, the price is 429 PLN/person (in words: four hundred twenty-nine zloty).
 - b) In the second ticket sale pool, purchased from November 16th, 2025 to December 31st, 2025 or until tickets are sold out, the price is 499 PLN/person (in words: four hundred ninety-nine zloty).
- 3. The price includes:
 - admission to the Event,
 - a seat at a table (the location and arrangement of tables/seats will be determined by the Organizer, optimizing the layout and ensuring comfort for all Participants),
 - coat racks for outerwear (the Organizer is not responsible for items left in the designated area, including valuables, jewelry, clothing, shoes, money, nor for their loss, theft, or destruction),
 - meals and beverages specified in the menu; however, the Organizer reserves the right to change ingredients of the listed dishes for reasons beyond their direct control. Each participant chooses one of three sets for the served dinner, which starts at 8:15 PM. The set should be selected at the time of ticket reservation, specifying the chosen set(s) in the transfer title (SET A VEGETARIAN, SET B FISH, SET C MEAT). Around midnight, a glass of champagne will be served. The hot and cold buffet, coffee and tea from urns, water, and classic lemonade in carafes will be available throughout the Event. Other beverages are to be paid for at the bar, according to the current price list,
 - waiter service,
 - musical entertainment: live music/ DJ, karaoke.

- 4. The Participant is not entitled to a refund of the purchased ticket except in the cases specified in subsections 5 and 6 below.
- 5. The Organizer reserves the right to cancel the Event without prior notice to Participants, due to reasons beyond the Organizer's control. In such a case, the Participant is entitled to a full refund of the fee paid.
- 6. The Organizer reserves the right to cancel the Event no later than 3 days before the scheduled date if the minimum number of participants is not reached. In such a case, the Participant is entitled to a full refund.

Rights and Obligations of the Event Participant

- 1. The Participant is obliged to:
 - a) carry an identity document,
 - b) occupy the seat assigned by the Organizer,
 - c) behave lawfully and in accordance with the principles of social coexistence, including not endangering their own safety or that of others,
 - d) comply with the orders and instructions of the Organizer, staff, and if relevant, the Police, Fire Department, Border Guard, Military Police, or other authorized services,
 - e) inform the Organizer or security of any fire, threat to life, health, or property, and of any disturbance or security issues.
- 2. The Participant has the right to:
 - a) be present at the venue for the duration of the Event, i.e., from the start to the end,
 - b) participate freely in the party and express emotions, subject to compliance with legal regulations, general rules of social coexistence, safety, and these Rules,
 - c) use devices, including sanitary facilities, made available for general use, in accordance with their intended purpose.
- 3. The Participant is not allowed to bring beverages, especially alcoholic beverages, or food products onto the premises. In case of violation, the Participant will be charged for the brought items at the price of a similar product sold by Oria Magic House.

§4

Event Safety

- 1. Only persons with a valid ticket who are over 18 years old are allowed at the Event.
- 2. It is forbidden to bring: weapons, explosives, pyrotechnic articles (e.g., firecrackers, sparklers, flares, torches), fire hazardous materials, drugs, psychotropic substances, or items that may threaten life or health (e.g., baseball bats, batons, metal pipes, knives, etc.).
- 3. The Organizer reserves the right to inspect clothing and luggage of persons entering or present at the Event in order to maintain order and safety. Persons refusing to submit to this inspection will not be admitted or will be asked to leave without the right to a ticket refund.
- 4. During the Event, security will be provided; the venue is under 24-hour security surveillance of the Brabank complex. The premises are also monitored and equipped with an emergency button for immediate security intervention.

- 5. The Organizer may refuse admission to a Participant on justified safety grounds without any financial claims from the Participant, specifically in the case of:
 - a) refusal to submit to verification of eligibility to participate,
 - b) being under the influence of intoxicants, psychotropic substances, or similar agents,
 - c) behaving aggressively, provocatively, or in any other way that threatens public safety, order, or other Participants.
- 6. For safety reasons, the Organizer may require a Participant to leave the Event and take steps to enforce this. This applies in particular to Participants disturbing public order, behaving aggressively, or violating these Rules. In such cases, the Participant will not have any financial claims against the Organizer.
- 7. Persons showing symptoms of illness or any health problems are required to immediately notify the Organizer.
- 8. The Participant acknowledges and accepts that the Organizer is not liable for possible infection with the SARS-CoV-2 virus or any other diseases or infections during the Event. The Participant waives all claims in this regard and participates solely at their own risk.

§5 Additional Provisions

- 1. The Organizer does not guarantee pyrotechnic attractions during the Event.
- 2. The Organizer does not provide a depository for items which are prohibited during the Event.
- 3. Participants may be exposed to constant sound levels that could cause hearing damage. Additionally, stage and/or strobe lighting may be used during the Event, which may cause discomfort or other problems, especially for persons with epilepsy.
- 4. Participants are responsible for any damage caused by them and are obliged to pay for it within 7 days of its occurrence.
- 5. The Organizer is not responsible for obstacles in the execution of the Event arising from force majeure or solely from the actions or omissions of the Participant. The Organizer is not responsible for damage caused to the Participant by third parties, including other Participants.
- 6. Any complaints must be submitted orally during the Event or in writing within 7 days after the Event directly to the Organizer. The Organizer will consider the complaint within 14 days and provide a written response or inform the Participant in writing of the inability to respond within this period, stating the reasons for the delay and the anticipated date for handling the complaint, not exceeding 30 days.
- 7. The provisions of these Rules and Regulations may be changed at any time as a result of orders from relevant public authorities or the introduction of legal regulations, for which the Organizer is not responsible.
- 8. Any disputes arising in connection with the Event will be resolved amicably, and in the absence of an agreement, the provisions of national law shall apply.
